WATER BILL 5% INCREASE — Hoult-the water bill 5% increase comes about every year Wolfe-you are going to see a 5% increase, right now your paying \$5.73 per

1000 gallons, you're going to see an increase of .29 per 1000 gallons, making your monthly charge 6.02 per 1000 gallons. So roughly an increase of \$3.48 per year per 1,000 gallons. That won't even pay for my electricity, Paris takes a 3% increase I raise 5%, that covers the 3% the other 2% covers my chemical, electricity, salary increases.

Commissioner Wolfe moved and Commissioner Owen seconded that the council authorizes the 5% increase in water bills as of 1/2/2025 as stated in the ordinance. Voting aye on the matter were all members present, voting nay none.

Wolfe- it's your department and if you need him to be a supervisor over your guy. You're giving him a dollar and your saying of you hire someone that we won't need to be supervised then you're going to snatch it back. That's what you're telling him.

I'm thinking the more a learn about it it's going to smooth it out, I'm thinking that we will take it back over. Wolfe – I don't have a problem with them having it, my problem is are they bonded.
