Jacob Lewis – Is there a time frame of getting the play equipment repaired? Alex was instructed to order the equipment that he needs to do the repairs.

Also, someone had damaged the story walk, I did take the time to repair it. Moore – Thank you!

Matt Johnson – FEHR Graham, I was asked to attend this meeting by Bryan Haddix. He was asking to give an update on the progress of the sewer system. Mr. Johnson was asked numerous questions from the commissioners. The purpose of the meeting was to determine if the City of Chrisman is to continue with FEHR Graham or hire a new firm. Matt informed them that the first step is to come up with the Project Plan for the Lagoon. Moore – do you have an estimate cost for that? Matt- \$10,000 to \$15,000. Wolfe – what are you going to do (to Commissioner Haddix)? Haddix – I'll stay with him but I'm not going to spend more than \$10,000. We have already spent \$200,000 dollars, if we don't stay with him, we lose that, if we do stay with him, we need to have a good price. Wolfe – and you need to have something in writing that guarantees that we can build this Lagoon. Haddix – lets proceed with the core samples.

We need to take care of this stuff before someone gets hurt. We will be sending out some letters this week. Wolfe – there was an agreement from a previous council that all money from the video machines would go toward tearing down houses.

Ameren will be moving our transformer back into the park where it belongs with no charge. It will be back and in operation before the fish fry.

We order Chrisman lights for the band stand; we got them on sale.

We had vandalism on the new track in the park.

I talked to Prairie Press about not publishing the 30-day notice, they said the most they could do was not charge us for the publishing. It cost us \$9,000.

Cheryl Gill is going to meet with us this month, she is former Mayor of Metcalf and very good at writing grants.
